Statement of Eligibility

I, the undersigned, represent that I am at least 18 years old; that neither I nor any of my immediate family members are employees, directors, interns, or officers of the U.S. Government, including the U.S. Department of State and the Department of the Treasury, or the Alliance for Innovative Regulation Institute (AIR) (collectively, “Organizers”) of ASET Global Virtual TechSprint 2022 (the TechSprint) or affiliated with any employees, directors, interns, officers, or contractors of any agencies, companies or entities involved in the administration, advertising, judging, execution, and/or fulfillment of the TechSprint; and, further, that I meet any and all other conditions of eligibility set forth in the TechSprint Official Terms and Rules (the “Rules”).

Submission License and Liability/Publicity Release

I represent and warrant that I have read, understood, and agree to comply with the Rules. I warrant that I will be one of the authors and creators of the solution that my team develops in the course of participating in the TechSprint; that my team will obtain any and all requisite licenses/permissions/consents and releases (collectively, “permissions”) to use any third party material that my team may choose to include in its solution (“solution”) and associated visual presentation aid submission (“submission”); and that any and all such permissions will extend to the same use by Organizers of any such third party material as may be contained within my team’s submission. I warrant that my team will obtain written consent from any and all individuals whose image or likeness may appear in my team’s submission, or from the parent or legal guardian of any such individual if s/he is considered to be a minor in his/her country of residence.

I agree to grant and hereby grant to Organizers a worldwide, non-exclusive, royalty-free, perpetual, sub-licensable, and transferable license to reproduce, prepare derivative works of, distribute, perform, display, and otherwise use my team’s submission in connection with the TechSprint in any media formats and through any media channels. Additionally, I agree to grant and hereby grant to Organizers the right to photograph, film, and otherwise record, by any means, my name, image, likeness, and voice (“my Likeness”) in connection with my participation in the TechSprint; and to reproduce, distribute, perform, display, and otherwise use any such record or recording containing my Likeness in their public information and promotional programs and activities. I acknowledge that these indemnification and hold-harmless obligations will survive indefinitely beyond the conclusion of the TechSprint.
